## **KODESH (JEWISH STUDIES) VOLUNTARY CONTRIBUTIONS**

### **What are the Kodesh Voluntary Contributions and why does the school need them?**

The school receives no State or other direct funding for the Kodesh Education it provides. As a charity we provide the teachers and resources for the Kodesh Education and extra-curricular kodesh activities which all pupils receive. We therefore ask parents for voluntary contributions to help cover the cost of providing the Kodesh Education.

### **Are contributions really Voluntary?**

Yes, contributions are voluntary and are a charitable donation. [There is no obligation for any parent to make any contribution. However, your contribution supports and maintains the ethos of the school and enables all our pupils to benefit from the excellent levels of Kodesh Education, which we would otherwise not be able to provide. Pupils at the school will not be treated differently according to whether or not their parents have made any contribution.](#)

### **How much is the suggested Kodesh Voluntary Contribution?**

Where parents are able to do so, the suggested voluntary contribution is £2,250 per child per year. Where parents can contribute more, this is always appreciated. Contributions can be made annually, termly or monthly by Standing Order.

### **Can I claim Gift Aid?**

Yes, Kodesh contributions **are** eligible for Gift Aid relief since these are considered charitable contributions but only provided that a Gift Aid declaration has been signed. In this case the suggested contribution sum may be reduced.

Gift Aid allows the school to claim from the government 25p for every £1 donated to the charity, provided that the donor is a tax-payer and has signed a Gift Aid Declaration. If you have not already signed a Gift Aid Declaration or to request a new Gift Aid Declaration form please email [akirby@nwljds.org.uk](mailto:akirby@nwljds.org.uk). In addition, should you be eligible, higher rate tax relief is available on gift aided donations.

### **Can I contribute using Charity Cheque, Business Cheque or a Charitable Trust Account?**

Yes, Kodesh Contributions can be made by charity voucher (including Achisomoch, KKL and **SOFTCAF**) or via a Business or Charitable Trust Account. We request the full suggested contribution in these instances, as these payments are not eligible for further Gift Aid.

### **What happens if I cannot afford to contribute?**

We do ask that parents contribute as much as they are able. For those who are financially unable to contribute, please contact Angela Kirby, Administrator to the Trustees, in the strictest of confidence. This will enable us to seek contributions from other sources to cover the cost of the Kodesh Education Department.
